## TERMS & CONDITIONS

**Conditions of registration:** The organizer confirms the registration with his own choice. Applications from exhibitors may be refused without giving reasons. It is only with the counter-signature of the form overleaf that the agreement is concluded. The exhibitor must indicate the correct and complete name and address of the company (according to the commercial register) and may not use misleading designations and data. The exhibitor owes the organizer the total amount of the stand rental as well as the registration fee, even in case of cancellation by the exhibitor or the non-appearance of the exhibitor at a trade fair regardless of the reason. In addition, the organizer reserves the right to dispose of exhibitors who are not related to the exhibitors from three hours prior to the opening of the fair, and to continue to rent them to the original exhibitors.

**Product presentation:** The exhibitor is responsible for the selection of products and services. The organizer merely acts as a landlord of stands and does not influence the selection of products and services of exhibition stands, unless these do not correspond to the exhibition theme (erotic fair) or violate statutory decrees and regulations (see, among others, STGB 197 «Pornographie»). In the event of a change of products and services indicated overleaf, the exhibitor shall inform the organizer at least 20 days before the start of the fair (date of the postmark). The organizer will notify the exhibitor in writing if the changes are accepted or not.

**Technical installations:** Technical installations are carried out by a production company designated by the organizer. A «form for additional orders» will be sent to the exhibitor. All the necessary information as well as ordering and conditions are documented. The order periods must be observed in order to ensure delivery and installation. All technical installations are carried out by the production company and invoiced directly to the exhibitor.

**Payment conditions:** The organizer will provide the exhibitor with an invoice for the total amount, which has to be paid within 30 days after receipt of the exhibitor application. This invoice is payable without deductions. The right to set-off is excluded.

**Contract resolution:** The organizer reserves the right to terminate this contract at any time with the exclusion of compensation claims by the exhibitor to the organizer, among other things. But not only in the following cases: non-complete or non-payment of the invoice for the rent according to the agreed payment terms. Violation of the law, regulations and official decrees (eg STBG 197 «Pornography»). Non-observance of the general provisions of the house rules, instructions and provisions of the exhibition hall, the police regulations and the safety regulations.

**Placement exhibition stand:** The organizer will distribute and place the exhibition stands. An allocated stand can be provided by the organizer before each fair must be changed to the exhibitor with prior notification, but must be the same size as the originally allocated stand.

**Sub-rent:** The sub-renting of measuring stands is prohibited, but can be granted by the organizer by submitting a written application. Surcharge: CHF 500.-, payable before start of the fair.

**Establishment of exhibition stands:** An information stand of the organizer will be open for the exhibitors during the set-up and dismantling (office hours) as well as during the opening hours of the exhibition. All stand personnel, including the staff, of every exhibition stand must be an official trade fair badge in the event locations which can be worn not only during the official trade fairs, but also at any time during assembly and dismantling.

**Access by vehicles for set-up and dismantling as well as product delivery:** An access schedule with timings is given to every exhibitor. The exhibitor must always carry this document with him. Stand mounting and dismantling may only be carried out within the times specified by the organizer. A control of the stands is provided by the organizer carried out. A person responsible for the stand must always be present at the stand during the set-up and dismantling periods, as well as during the official opening times.

**Decoration and assembly of exhibition stands:** The exhibitor is responsible for setting up and installing the stand. The installations must be non-combustible and non-smoking. Decorations with Sagex and Polivinyll are strictly forbidden. Each exhibitor is asked to inform himself in advance about the situation, the exact dimensions and building options of his / her stand. The exhibitor is liable for all damages that arise during the assembly and dismantling of his stand. The exhibitor is responsible for all the thefts within the exhibition stand during the set-up and dismantling, the official trade fair opening times and the opening hours for exhibitors.

**Inscription:** The exhibitor is obligated to inscribe his stand using text or logo resp. (With official company name according to HR / tax office).

**Distribution of advertising material:** Any distribution of advertising materials such as brochures, brochures, gadgets, etc. outside of the registered own exhibition stand is prohibited. The organizer has its own booth at the entrance, where exhibitors can display their own advertising materials. These are issued free of charge for exhibitors.

**Removal:** The same provisions apply to dismantling as for construction. The exhibitor is responsible for the dismantling and removal of all his material incl rented stand. All material must be transported to the last agreed exhibitor-demo days completely by 12 noon from the event area. Thereafter, the organizer will remove and destroy all material under the incontestable expense of the exhibitor.

**Obligations of the exhibitor:** The exhibitor undertakes to keep his exhibition stand open during the entire opening hours of the trade fair (s) and to keep staff occupied. The exhibitor must exhibit his products throughout the fair. It is forbidden to sell products outside of the fair (ie also outside of the own exhibition stand) or in close proximity to the trade fair.

**Requirements for exhibitors:** Any levy (free or paid) of food and drinks is strictly forbidden to the exhibitor. Any harassment or noise emission must be prevented. Sound & lighting systems, etc. must be operated with moderate volume and without affecting other exhibitors or the fair as a whole. There must be no disc-jockey (DJ). All sales items have to be marked according to the price. Price notification regulation. The organizers' instructions must be immediately complied with at first request. Injured products and / or services of an exhibitor to the organizer, the exhibitor shall, at the request of the exhibitor, immediately terminate these products and / or services. Remove the goods immediately from the venue.

**Exhibitor's rights:** Videoprojections as well as TV, LCD, plasma screens and PCs are permitted, but no other exhibitors or the trade fair may be affected. Performances and shows are allowed to the exhibitor with the prior written permission of the organizer. Corresponding inquiries must be submitted to the organizer in writing at least 45 days (postmark) before the start of the fair. The organizer will inform the exhibitor in writing.

**Goods receipt:** At the request of the exhibitor, the organizer can assist the exhibitor in the import and export of goods (creation of a carnet ATA). The Corresponding customs duties and import taxes will be borne by the exhibitor.

**Exclusivity:** Goods, labels or engaged persons (eg actors, Gogo), exhibited by the exhibitor or the exhibitor who have a direct or indirect connection with the exhibitor (eg partners, sponsors, friends, acquaintances, family, etc.) and dancers, striptease dancers, filmproducers, filmmakers, etc. may not perform at any other public or private event (eg trade fairs, discotheques, bars, cabarets, parties, shop shops etc.) within a radius of 100 km be advertised. The exhibitor guarantees the personal exclusivity of the people involved in the fair.

**Final Provisions:** Is the event canceled prior to the start of the fair, existing leases are automatically terminated. Already paid stands are repaid. There are no further claims on the part of exhibitors. The exhibitor is obligated to sign the contract for compliance. He also declares that he is liable for all other costs which he has to indemnify under this contract for the erection against the organizer or third parties. The exhibitor shall notify the organizer in writing of any defects and complaints in writing up to a maximum of 10 days after the event has ended. After this, no deficiencies and complaints can be registered or claimed. If an exhibitor violates this contract or instructions of the organizer or official instructions, the organizer has the right to close the corresponding test stand. In this case, the exhibitor shall not make any claims against the organizer. Already paid stands are not repaid. The organizer reserves the right to exclude the exhibitor from future events. If an exhibitor violates this contract, legal regulations, regulations or official instructions, in particular against articles STGB 187 to 212, his stand can be closed immediately. The exhibitor shall not be entitled to any claims against the organizer.

The exhibitor authorizes the organizer to use his company names and brands which he represents in his communication media (press release, website, advertising material, plans, photos, etc.) without compensation. This agreement covers all the agreements between the two parties. All other agreements shall be legally binding and shall form an integral part of this agreement. **The courts in Zofingen AG are responsible for disputes which can not be solved by mutual agreement. Swiss law applies.**
